Kumite Rules:

Kumite (Sparring) - 3-point matches for under black belt, 5-points black belts. No time limit. Flag Sparring - 1-minute time limit. Each time out of bounds loses 1 flag. No kicking, punching, uniform grabbing, or bear hugging. Falling on the ground results in loss of one flag. Ages 4-12, novice and intermediate ranks only.

Scoring:

Controlled contact to padded area of headgear, face shield, stomach, ribs, and chest target areas.

No groin strikes No knee strikes No strikes to back or spine No blind techniques No strikes below the belt level Light face contact Adult Black Belts Only Sweeps in black belt divisions only Single elimination rules - all sparring and flag sparring divisions.

The tournament promoter reserves the right to combine divisions.
